

ICA Rule Proposals - 2024

Number of Perfs SUBMITTED BY STEVEN DUBY

All rodeos with 3 performances or more are required to add \$1500 dollars minimum in each event **TABLED**

Minimum added money SUBMITTED BY STEVEN DUBY

All rodeos with less than \$999 added money will be double entries in the timed events **TABLED**

Equal money SUBMITTED BY STEVEN DUBY

All rodeos that do not have equal added money in all events will be double entries in the timed events **TABLED**

***Timed Event Entry Fees* SUBMITTED BY STEVEN DUBY**

All entry fees in all the timed events will be \$150. With \$10 going to Judges and Timers, \$8 going to Finals Fund \$5 going to committee fee, \$10 to Event finals added money, \$7 to office fee (high call and ICA office) and remainder going into the pot **PASSED**

Double entries SUBMITTED BY STEVEN DUBY

If double entries is offered in any one event it is required to be offered in all events **TABLED**

Non- Member Entries SUBMITTED BY STEVEN DUBY

Non- Members are allowed to enter any and all rodeos. They will be required to pay a \$30 association fee per each entry at each rodeo. They will receive no

preferences. They will be required to be placed before the member entries in all timed events excluding barrel racing. In the barrel racing they will be required to be placed at the bottom of the drag. (If 12 entries in a perf and 3 are non-members they will be placed at #6 #11 & #12 If 8 entries and 1 non-member entry they will be placed at #6 If 13 entries they will be placed at #13 and WILL NOT receive a drag **PASSED \$50 FOR NON MEMBER FEE PER RODEO PER ENTRY**

Blacklisted stock SUBMITTED BY STEVEN DUBY

If a timed event animal does not give contestant an equal opportunity to compete the event director has the ability to blacklist the animal by number after said rodeo has finished. If the animal is brought to another rodeo and placed in the draw, the event director has the authority to claim a misdraw and pull said animal from the draw. Even if that means there is not enough animals to compete on. The remaining runs on the cattle will be drawn from the herd as many times as necessary.

Timed Event Barrier SUBMITTED BY STEVEN DUBY

The event director has the authority to set the barrier at all rodeos as they see fit according to arena conditions, box measurements and cattle, within the regulations.

P. Arena Regulations (2022) SUBMITTED BY DEBBIE SCOTT

1. No unauthorized person shall be allowed in the Arena during a rodeo performance.
2. The management assumes no responsibility or liability for injury or damage to the person, property or stock of any owner, contestant or assistant. Each participant by the act of his/her entry waives all

claims against the management and/or owner(s) for injuries to any property, animal, self or persons may sustain.

3. The management of each ICA approved rodeo or event shall be required to provide an ambulance and adequate first-aid facilities for all performances and contesting incidents, including slack. QRT with a minimum of 2 EMT's may be used if Ambulance is within 10 minutes of the event.**PASSED**

4. The management of each ICA approved(**PRIME**) rodeo or event shall be required to provide a conveyance to remove any animal hurt during a performance and slack.

E. Contractors If a contracting Card holder does not have a Prime Rodeo within a rodeo season , the contractor's card goes into a probation period for that rodeo season. The contractor must pay for his card for the card to remain active. The year following the probation year, the contractor must have at least one ICA Prime Rodeo under said card, or that card will become invalid/deactivated. A contractor whose card is deactivated will be required to meet the requirements of a New contractor in order to reactivate said card.

B. Selection of Personnel

3. Timers for the finals must have an ICA card and timed at least one ICA Prime ~~approved~~ Rodeo.

C. Selection of Stock

1. All timed event cattle and rough stock animals for the Finals rodeo will be selected from ICA stock producers and have been run at least twice at an ICA Prime approved rodeo.

2. It will be the event Directors responsibility to select the timed event stock for the finals. If there are no ICA stock contractors or subcontractors who have provided cattle to at least two ICA Prime rodeos with enough desirable animals for the Finals, cattle from different ICA stock contractors and subcontractors may be split to make an even pen if desired.

3. Tie Down Roping. Calves that have gone to at least two ICA Prime rodeos by the time the dates for the finals may be too big or not desirable. If this is the case an ICA Stock Contractor or subcontractor who has provided tie down calves to at least two ICA Prime rodeos may put together a new herd.

****Rule Proposals for 2025 (Will Continue to Update - If It's 30 Days Out)** SUBMITTED BY ASHLEY LAWSON**

Note: This rule was voted on last fall (2023) and was not included in the rulebook to take effect.

- payout to pay no less than the entry fee (e.g., if the entry fee is \$140, no lesser amount is to be paid out.)

Ground:

1. ****Raking****: All rodeos must mandatorily rake the ground after every 6 entries (non-condensed), using the same implement that was used at the start of the rodeo. Hand raking may be used in addition but cannot replace the initial implement. **PASSED**

- The implement used before barrels must remain consistent for all rakes, including slack and performance. For example, if a tractor is used at the start, it must continue to be used, and cannot be replaced by a different implement, such as a harrow with ATV/Razor

2. ****Rake Monitoring****: The judge is responsible for monitoring and inspecting the raking.

3. ****Ground Issues****: If the performance is stopped due to ground issues, any contestant who ran before the ground was reworked has the option to rerun immediately afterward or at the end, maintaining the same position on the ground.

4. ****Pre-Slack Raking****: The ground must be raked before the start of any barrel slack.

5. ****Conduct****: An automatic \$250 fine will be imposed for cursing or yelling at committee members or the tractor driver.

6. ****Draw Errors****: If the draw is posted with errors due to the entry system, a redraw of the event is required. And posted to notify.

7. ****Barrel Pattern Posting****: The barrel pattern must be posted prior to the start of the first performance or slack, whichever occurs first.

8. **Subject: Rodeo Rule Proposal for Posting Times**- The proposal suggests that times from slack or performance events should be posted for all participants to view prior to the next event, whether it be slack or performance.

Timer:

1. ****Timer Malfunction****: In the event of a timer malfunction requiring a hand time, the judge must notify the contestant and offer the option to rerun or keep the hand time.

2. ****Notification of Hand Timing****: If a hand time or alternate timer is used, it must be posted on the judge's sheet for all contestants to see. Contestants must also be notified of the change.

3. ****Contestant Passes****: All rodeos are required to provide contestant passes and companion passes, as this is a family sport. **FAILED**

4. ****Companion Passes****: Regarding rule proposal number 3, it is up to the committee to decide, but they must state this in the ground rules and provide at least one companion pass. **PASSED**

13. Apparent Injury During Competition

Should a riding event animal show evidence of injury caused by the contestant in the competition arena, that contestant will be fined \$250 for the first offense and \$500 for the second offense, and \$1,000 for the third offense and subsequent offenses. The number of offenses reported for a particular contestant will be started afresh with each Rodeo Year.

Lining for Timed Event Boxes. In order to protect the contestant's horse, the back and the side opposite the timed event chute of timed event boxes shall be lined from a minimum of 4 inches under ground level (unless properly supported by other means) up to a minimum of 3' high with a solid panel (metal or no less than 3/4" thick plywood). Box pads are likewise required for each timed event box. Failure to do so shall result in a fine to the Rodeo Committee of \$250 per performance or section of slack

4. Add VI G 8 **SUBMITTED BY SCOTTI ERICKSON** **TABLED**

Failure of Animal to Pull Neck Rope. In the timed events, if an animal fails to break the neck rope and time is officially started by the contestant, that animal belongs to the contestant. A contestant cannot rope an animal before the neck rope comes off. However, if an animal starts the time and then stops before the neck rope comes off and the contestant declares immediately, he will be entitled to a rerun, as long as in the opinion of the judges, the stop was not caused by the hazer or the heeler.

5. Add VI G 9 **SUBMITTED BY SCOTTI ERICKSON** **FAILED**

In the breakaway roping, if an animal trips or falls before breaking the neck rope, the judge can issue a rerun without the contestant declaring.
